HOUSTONIANS ARE ACHING FOR A NEW AND PROGRESSIVE STRATEGY TO END THE KILLING OF ANIMALS IN SHELTERS. THE MEDIA COVERAGE IS PASSIONATE AND YET UNTIL FRIENDS FOR LIFE (FFL) STARTED THE NEW PROGRAMS, NOTHING HAD CHANGED IN THE HOUSTON SHELTER MODEL SINCE 1924.

EVEN AMONG NO KILL PROGRAMS, FFL IS UNIQUE IN ITS ENGAGEMENT WITH THE COMMUNITY. RATHER THAN EXCLUSIVELY TAKING ANIMALS FROM CITY OR COUNTY AGENCIES, FFL IS A PARTNER TO THE COMMUNITY AS A WHOLE AND ACCEPTS

FFL HAS SURPASSED THE 4,600 MARK IN FREE SURGERIES WE HAVE GIVEN TO THE COMMUNITY. FFL'S FIX HOUSTON PROGRAM IS THE FIRST OF ITS KIND IN HOUSTON TO FORGE A PUBLIC/PRIVATE RELATIONSHIP WITH THE CITY. THE CITY INTAKE/EUTHANASIA RATES HAVE DROPPED IN THE AREAS WHERE WE CONDUCT THIS PROGRAM.

THE FIX HOUSTON INITIATIVE HAS PROVIDED OVER 4,600 FREE SPAY/NEUTER SURGERIES FOR THE ANIMALS OF HOUSTON FAMILIES SINCE ITS CREATION IN 2013. THIS HAS PREVENTED OVER 80,000 BIRTHS. IT ALSO INCLUDES A TARGETED TNR PROGRAM THAT HAS STABILIZED FERAL COLONIES IN THE ZIP CODE
