HOUSTONIANS ARE ACHING TO END THE KILLING OF ANIMALS IN SHELTERS. THE MEDIA COVERAGE IS PASSIONATE. YET, UNTIL FFL STARTED NEW AND PROGRESSIVE PROGRAMS, NOTHING HAD CHANGED IN THE WAY HOUSTON ANIMAL SHELTERS WORKED SINCE 1924.
